# Definition of payslip terms

The following terms may appear on your payslip:

## Payments

---

<b>Description</b>	<b>Definitions</b>
ADDED YEARS	Original amount of added years compensation*
ADD PYT NT	Additional (one-off) non-taxable payment
BASIC PENS	Original amount of pension
INJ PENS	Original amount of injury pension
OVERPYMT	Recovery of an overpayment deducted before calculation of tax
PI ADD YRS	Pensions increase on added years compensation*
PI BASIC	Pensions increase on pension
PI INJ PENS	Pensions increase on injury pension

<b>Description</b>	<b>Definitions</b>
COURT ORD	Deduction by court order
FSNB FUND	Fire Service National Benevolent Fund
G.A.Y.E	Give As You Earn charity donation
INCOME TAX	Tax deducted from pension
LOTTERY	Deduction for Fire Brigade lottery
OVERPYMT	Recovery of an overpayment deducted after tax calculated
REC AMOUNT	Recover of a sum of money deducted after tax calculated
